PUBLIC MEETING FOR THE PEWAUKEE LAKE MANAGEMENT PLAN UPDATE PROJECT

A public meeting has been scheduled to provide Southeastern Wisconsin residents with information about the Pewaukee Lake Management Plan (3rd Edition) Update Project that is being developed by the Lake Pewaukee Sanitary District and Southeastern Wisconsin Regional Planning Commission (SEWRPC). At the public meeting, attendees will learn more about the proposed lake management plan and be able to provide comments on the plan outline and content. The meeting will be held:

The informational meeting has four main goals: 1) review the proposed plan outline and content; 2) present timeline for completion; 3) provide a brief history of management on the Lake and information being assembled to date; and 4) identify important issues and concerns related to Pewaukee Lake. There will be an opportunity for property owners, residents, and people who use Pewaukee Lake for recreation to complete a questionnaire and submit comments about lake management issues and concerns.

“The purpose of the plan update is to use current science and technology to bring the Pewaukee Lake management recommendations up to date,” said SEWRPC Principal Planner Thomas M. Slawski, Ph.D.,

who is managing the plan for SEWRPC. “The plan will address aquatic plant management, fish and wildlife populations, and shoreline maintenance issues, as well as provide recommendations that could be implemented upstream to address lake management issues at their source.”
